

## **Notice of Passing of Development Charges By-laws**

Development Charges Act, 1997, S.O. 1997, c.27

**TAKE NOTICE** that on Wednesday, July 10, 2024, the Council of The Corporation of the City of Brampton passed By-laws No. 110-2024, 111-2024, 112-2024, 113-2024, 114-2024, 115-2024, 116-2024 and 117-2024 and 126-2024 under Section 2 of the *Development Charges Act, 1997*, which imposes City-wide development charge rates.

**AND TAKE NOTICE** that any person or organization may appeal to the Ontario Land Tribunal in respect to the by-laws by filing with the Clerk of The Corporation of the City of Brampton, not later than Monday, August 19, 2024, a notice of appeal setting out the objection to the by-laws and the reasons in support of the objection.

Development charges are levied against new development to pay for the increased capital costs related to the provision of such City services such as By-Law Enforcement Services, Development - Related Studies, Fire Services, Library Services, Public Works, Recreation Services, Roads Services, Transit Services and General Government Services The development charges imposed by the by-laws are as follows:
