- 1. All records related to water drainage at 41 George Street and Elizabeth Street South properties. The request specifically includes:
  - a. Records pertaining to drainage during construction activities; and,
  - b. Records pertaining to water drainage from Elizabeth Street South onto 41 George Street.
- 2. All records related to interim easement agreements for use of Elizabeth Street South properties during construction of the City Hall expansion. The request specifically includes:
  - a. Records related to the review of draft interim agreements, including correspondence;
  - b. Communications between the City and Dominus; and,
  - c. The use of 2 and 4 Elizabeth Street South after January 31, 2014.
- 3. All records related to expropriation of lands required for the City Hall expansion. The request specifically includes:
  - a. Correspondence and emails (possible search parameters include: Dominus, Rosemary Graff, Mayor and Mayor's Staff email accounts); and,
  - b. Possible expropriation of properties on Elizabeth Street South.

- 4. All records related to the use of Elizabeth Street South properties to support construction of the City Hall expansion. The request specifically includes:
  - a. The potential use of Elizabeth Street South properties to construct shoring structures;
  - b. The City's supervision of Dominus' use of Elizabeth Street South properties; and,
  - c. Dominus' communications with the owners of Elizabeth Street South properties.
- 5. All records of complaints related to construction of the City Hall expansion. The request specifically includes complaints related to:
  - a. Damage to adjacent land and buildings;
  - b. Noise;
  - c. Dust;
  - d. Falling construction debris; and,
  - e. Bright Lights.
- 6. All records related to ground vibrations during construction of the City Hall expansion. The request specifically includes:
  - a. Monitoring;
  - b. Tests; and,
  - c. Records that relate to actual or anticipated vibrations affecting properties on Elizabeth Street South.
