


The Council of the Corporation of the City of Brampton ENACTS as follows:

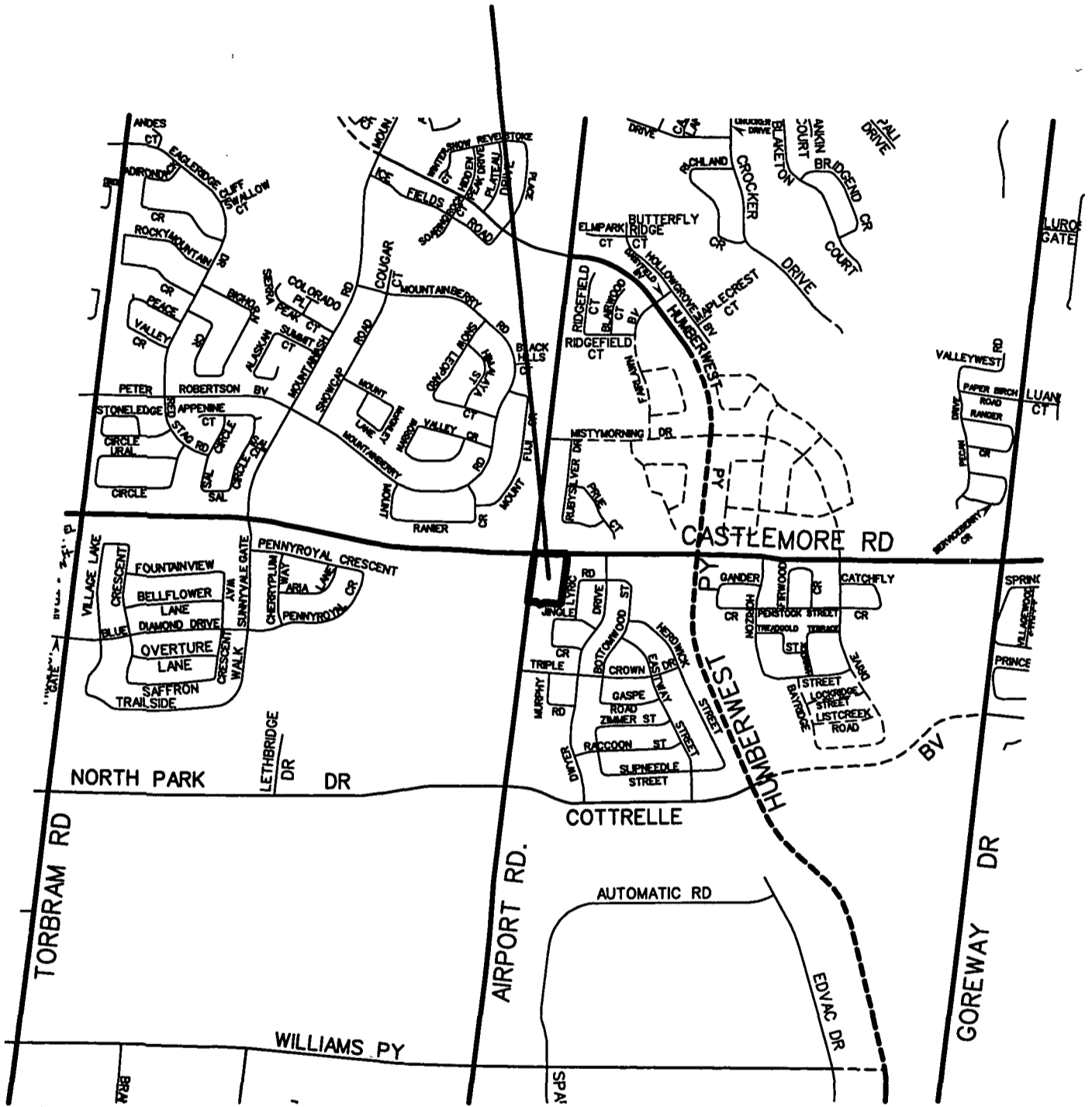
