
To appoint officials of the Corporation  
of the City of Brampton.


Whereas the Council of the City of Brampton has made certain recommendations regarding the appointment of officials effective January 1st, 1974.

4. That John F. Curran be and he is hereby appointed City Engineer.
5. That Leonard W.H. Laine be and he is hereby appointed Planning Director.
6. That Donald M. Gordon be and he is hereby appointed Parks and Recreation Director.
7. That Matthew J. Gowland be and he is hereby appointed Fire Chief.
8. That Lorne S. Thurston be and he is hereby appointed Building and Zoning Co-ordinator.
9. That Ralph A. Everett be and he is hereby appointed Deputy-Clerk.


