(1) by changing Schedule A thereto, the zoning designation of the lands as shown outlined on Schedule A to this by-law:

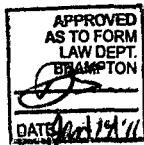

this 26th day of January 2011.

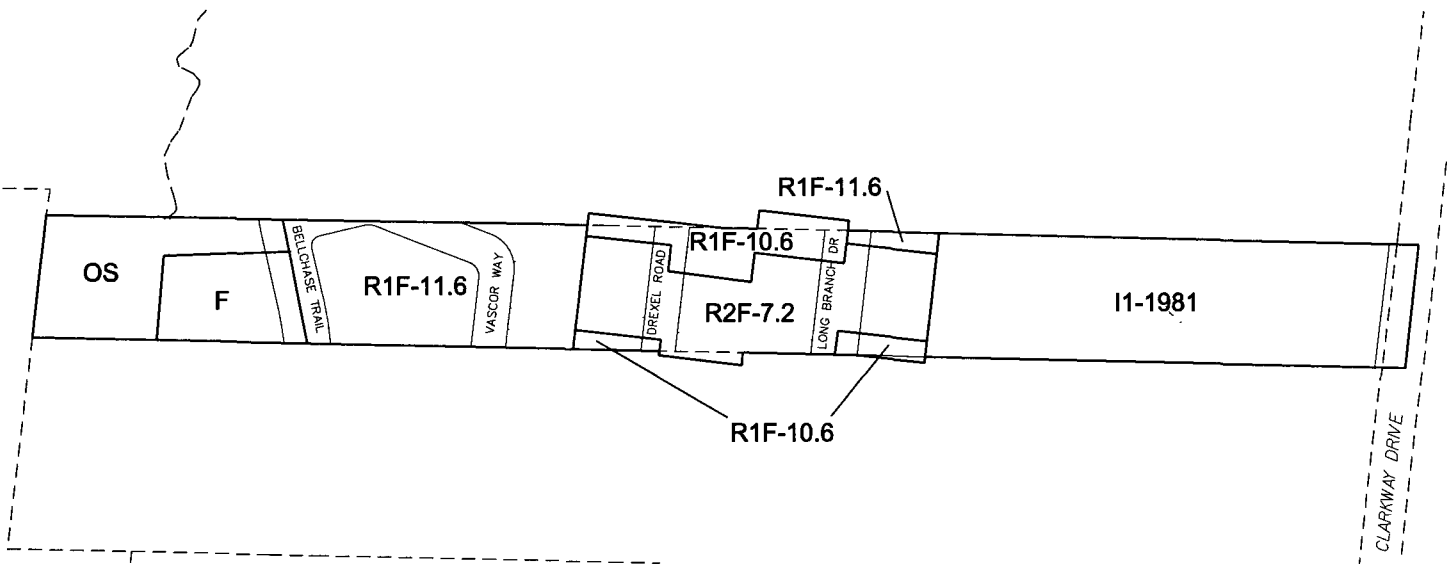

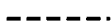
