

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW No. 7-74

Being a By-law to appoint a Lottery Licensing Officer and provide for licence fees.

WHEREAS the Municipal Act provides that the Councils of all municipalities may pass by-laws for appointing such officers and servants as may be necessary for the purposes of the Corporation.

AND WHEREAS it is deemed expedient to appoint a Lottery Licensing Officer.

AND WHEREAS by regulations made by the Ministry of Financial and Commercial Affairs a Municipal Council may set fees and charges for the issuing of such licences not exceeding such limits as may be prescribed by the Minister.

AND WHEREAS it is deemed expedient to set the fees payable for Lotteries.

Now therefore the Council of the Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. That Edward L. Hore is appointed Lottery Licensing Officer and James Paton Deputy Licensing Officer for the Corporation of the City of Brampton.
2. That the said Edward L. Hore and the said James Paton shall hold office during the pleasure of the Council and shall exercise all the authority, powers and rights and shall perform all the duties and obligations which by Statute or by-laws are or may be conferred or imposed upon the Lottery Licensing Officer and any other duties that may be imposed by Council.
3. Each application for a lottery licence shall be in the prescribed form and shall be accompanied by the appropriate fee in accordance with the schedule of fees attached hereto and forming part of this By-law.

SCHEDULE OF FEES

BINGO LOTTERIES

(A) For single Bingo Lottery Licence:

Where the sum entered at Section (3) of the application does not exceed \$500.00, a fee of \$2.00 (payable to Treasurer, Corporation of the City of Brampton).

Where the sum entered at Section (3) of the application exceeds \$500.00 and not more than \$3,500.00, a fee of 2% of the total value of prizes to be awarded (payable to Treasurer, Corporation of the City of Brampton).

Where the sum entered at Section (3) of the application exceeds \$3,500.00, a fee equal to 2% of the total value of prizes to be awarded. (Payable to the Treasurer of Ontario).

(B) For a series of Bingo Lotteries covered by one licence:

Where the sum entered at Section (3) of the application does not exceed \$500.00, a fee of \$2.00 multiplied by the number of lotteries to be operated in the period shown. (payable to Treasurer, Corporation of the City of Brampton).

Where the sum entered at Section (3) of the application exceeds \$500.00 and not more than \$3,500.00, a fee of 2% of the total value of prizes to be awarded multiplied by the number of lotteries to be operated in the period shown. (payable to Treasurer, Corporation of the City of Brampton).

Where the sum entered at Section (3) of the application exceeds \$3,500.00, a fee equal to 2% of the total value of prizes to be awarded multiplied by the number of lotteries to be operated in the period shown. (payable to the Treasurer of Ontario).

RAFFLE LOTTERIES

Where the sum entered at Section (2) of the application does not exceed \$3,500.00, a fee of 2% of the total value of prizes to be awarded. (payable to Treasurer, Corporation of the City of Brampton).

BAZAAR LOTTERY SCHEME

For each lottery type scheme to be conducted at a bazaar, a fee of \$10.00. (payable to Treasurer, Corporation of the City of Brampton).


In response to submissions by many Municipalities, it is my pleasure to announce that effective March 1, 1974, Municipal Councils' authority to issue a licence for a raffle lottery has been broadened to include a total prize structure of five thousand dollars (\$5,000.00) in cash or merchandise value. This represents an increase in the upper licencing limit for raffle lotteries of \$1,500.00 from the previous maximum of \$3,500.00.

It is certainly my feeling that we must continue to make absolutely sure that we retain control over all lottery activities and only liberalize the rules when we are convinced we have the expertise and capacity to control effectively.

In our experience in dealing on a daily basis with a wide range of Municipal Officials, it appears that most municipalities are having little or no difficulty in supervising local groups carrying on small lottery operations. Municipal Officials and Law Enforcement Officers acquainted with local conditions and local organizations are holding in check their own sectional activities with a high degree of excellence. May I add, it is my belief that the licencing of lotteries in Ontario has been remarkably successful because of the good working relationship between this Ministry and yourselves. Together with private organizations throughout the Province, we have been able to develop a strong defence against the unethical operator who might try to infiltrate the lottery field.

I assure you of our continued efforts to maintain this mutual trust, respect and co-operation and to be of assistance to you, and to all those bona fide organizations and groups in your municipality whose members give generously of their time, talent, and interest to raising funds for worthwhile charitable and community purposes.
