



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 21-80


To designate the Region of Peel Archives as a place appointed for the purpose of keeping certain documents.


WHEREAS Section 215(e) of The Municipal Act (R.S.O. 1970, Chapter 284, as amended) provides that the Council of the municipality may appoint a place, other than the office of the Clerk, for the keeping of the originals of by-laws and of minutes of the proceedings of Council;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The Region of Peel Archives is hereby appointed as a place to keep the originals of all by-laws and of all minutes of the proceedings of
 - (a) the Council of the former Corporation of the Village of Brampton, for the years from incorporation up to and including 1860,
 - (b) the Council of the former Town of Brampton, for the years from incorporation up to and including 1973, and
 - (c) the Council of the former Corporation of the Township of Toronto Gore, for the years from incorporation up to and including 1973.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 28th day of January, 1980.
