


To authorize the execution of an Agreement between The Corporation of The City of Brampton and The Regional Municipality of Peel.

MEMORANDUM OF AGREEMENT MADE IN DUPLICATE

THIS 28th DAY OF January 1980.

BETWEEN:

THE CORPORATION OF THE CITY OF BRAMPTON

HEREINAFTER CALLED THE "CITY"

OF THE FIRST PART

AND:

THE REGIONAL MUNICIPALITY OF PEEL

HEREINAFTER CALLED THE "REGION"

OF THE SECOND PART

WHEREAS The City has in its' possession certain documents, rolls and records as described in Schedule A (hereinafter referred to as the materials);

AND WHEREAS The City has designated the Region of Peel Archives as the place appointed for the purpose of keeping such materials:

NOW THEREFORE this Agreement witnesses that in consideration of the covenants hereinafter contained the parties hereto agree each with the other as follows:

1. THE REGION

- (a) Will accept and store the materials;
- (b) Will maintain all the materials according to accepted Archival procedures;
- (c) Will return to The City all or any of the materials provided written notice is given by the City;
- (d) Will make the materials available to the public for research purposes;

1. THE REGION (Cont'd..)

- (e) Is not responsible for the safe keeping of materials entrusted to it beyond the exercise of such precautions as are now in force, or may hereafter be put in force, for the safe keeping and preservation of its property;
- (f) Will insure the materials against loss or damage at valuation agreed upon between The City and The Region

2. THE CITY

- (a) Gives permission to reproduce these materials in any medium, but does not certify any copy to be true and correct.

In witness whereof the parties hereto have hereunto affixed their corporate seals under the hands of their proper officers duly authorized in that behalf.
