BY-LAW

Number 23-78

To Stop Up, Close and Authorize the sale of that part of the road allowance between Lots 10 and 11 in the Sixth Concession West of Hurontario Street.

WHEREAS that in accordance with the provisions of the Municipal Act notice was duly published once a week for four consecutive weeks:

AND WHEREAS the Council of the Corporation of the City of Brampton deem it expedient and advisable that this By-law be enacted;


NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

1. That part of the road allowance between Lots 10 and 11 in the Sixth Concession, West of Hurontario Street, being parts 1 to 7 on a plan deposited in the Registry Office (No.43) as Reference Plan 43R-4584, be and the same is hereby stopped up and closed.
2. That the sale of the land stopped up and closed by paragraph 1 of this By-law be and the same is hereby authorized to those persons and for the amounts shown on Schedule "A" attached hereto and forming part of this By-law, subject to an easement in favour of the Ministry of Transportation and Communications over Part 1 as shown on Reference Plan 43R-4584.

3. That the Mayor and Clerk be authorized to execute the Transfers to each of the abutting owners for that respective part of the road allowance outlined in Schedule "A" hereof.

READ a FIRST, SECOND and THIRD TIME and PASSED in OPEN COUNCIL this 23rd day of January, 1978.


