1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule IV thereto the following items:

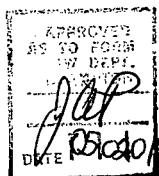


