Being a By-law to prevent the application of part lot control of certain plans of subdivision in the City of Brampton.

WHEREAS subsection 29 (4) of The Planning Act (R.S.O. 1970, Chapter 349, as amended) has imposed part lot control on all registered plans within the City;


AND WHEREAS, pursuant to subsection 29(5) of The Planning Act, the Council of the municipality may by by-law provide that such part lot control does not apply to lands within such registered plans as are designated in the by-law;

NOW THEREFORE the Council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. Subsection 4 of Section 29 of The Planning Act, does not apply to the land that is described in Schedule "A" attached hereto.
2. This By-law shall come into force upon approval thereof by the Regional Municipality of Peel.




