The Council of the Corporation of the City of Brampton ENACTS  
as follows:


By-law Number 5500 as amended is hereby amended by adding  
thereto the following Section 761:


- Section 761
1. Map Number 45 contained in Schedule 'B' attached to By-law Number 5500 as amended of the former Town of Mississauga is hereby amended by changing thereon from 'A' to 'M1' and 'G' for the property outlined as shown on Schedule 'A' of this By-law hereto attached.
  2. Notwithstanding the industrial zone, Section 109(c) of By-law Number 5500 as amended shall not apply to the land zoned by this By-law. In addition to the principal uses permitted by Section 110, only those commercial uses directly incidental to the principal industrial use shall be permitted provided that such use shall not exceed ten percent (10%) of the principal use gross floor area.
  3. Notwithstanding the 'M1' zone, no outside storage shall be permitted on the land zoned by this By-law.
  4. No building or structure of any kind other than those necessary for flood or erosion control shall be permitted on those lands zoned 'G' by this By-law.
  5. Schedule 'A' hereto attached forms part of this By-law.

6. This By-law shall not come into force and effect until and unless approved by the Ontario Municipal Board.

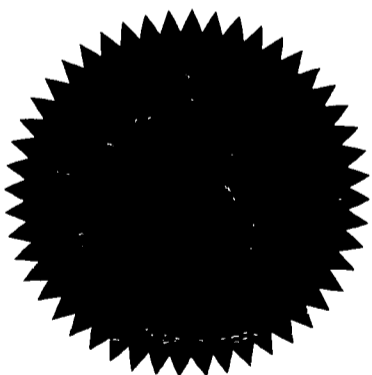
