
The council of The Corporation of the City of Brampton ENACTS as follows:

1. Schedule A to By-law 861, as amended, and as specifically amended by By-law 37-85, is hereby further amended by changing the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL R6 - SECTION 401 (R6 - SECTION 401), RESIDENTIAL MULTIPLE RMA - SECTION 404 (RMA - SECTION 404), CIVIC AND PUBLIC CAMPUS - SECTION 407 (C.P.C. - SECTION 407), and CONSERVATION AND GREENBELT (G) to RESIDENTIAL MULTIPLE RMA - SECTION 404 (RMA - SECTION 404) and CONSERVATION AND GREENBELT (G).
2. Schedule A to this by-law is hereby attached to By-law 861 as part of Schedule A and forms part of By-law 861.

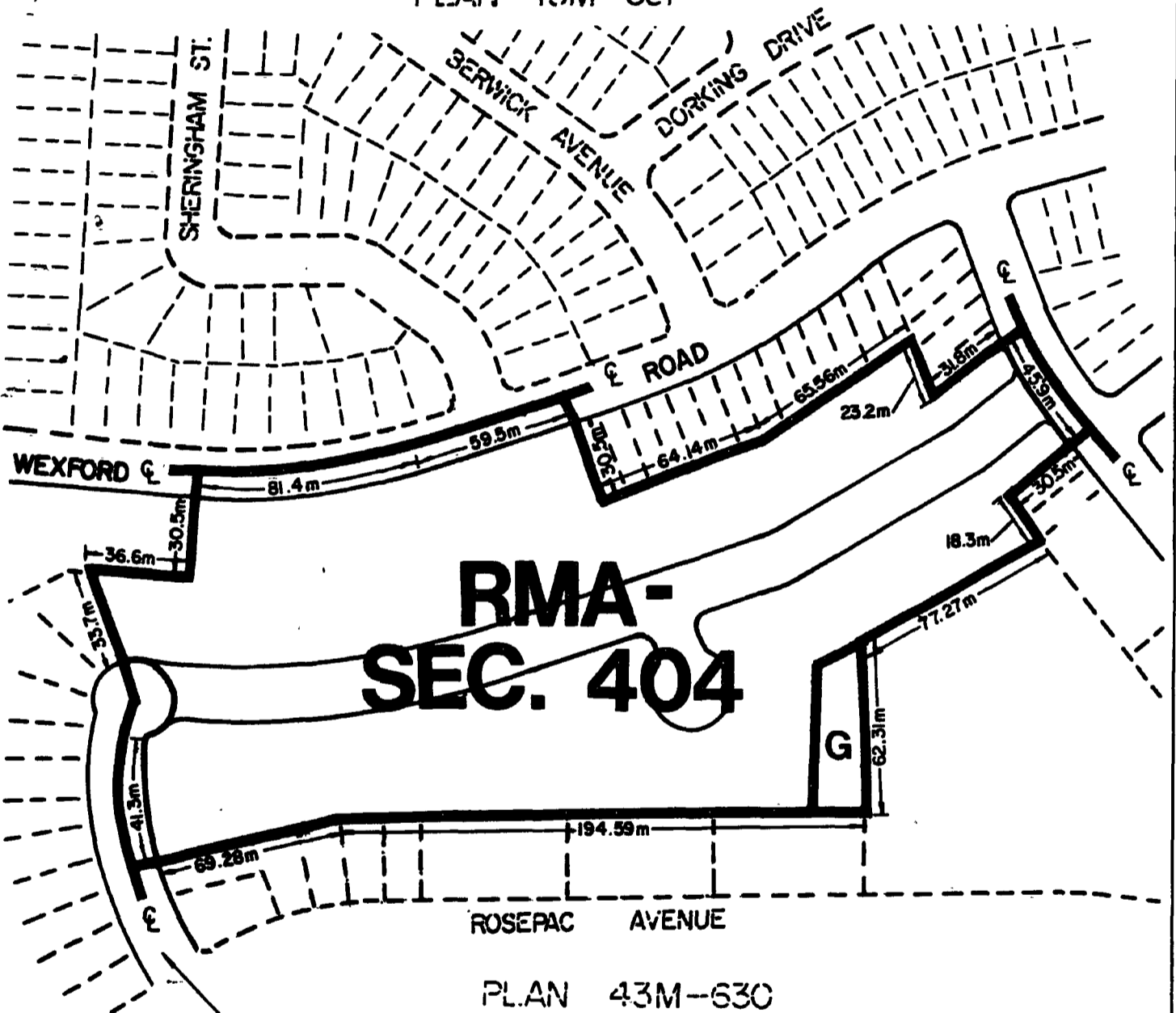

DECLARATION


I, LEONARD J. MIKULICH, of the City of Brampton, in the
