# BY-LAW

Number 89 - 2024

**To amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), NO PARKING (Schedule XIV), FIRE ROUTES (Schedule XXII), COMMUNITY SAFETY ZONES (Schedule XXIV), RATE OF SPEED (Schedule X) and Designated Bicycle Lanes (Schedule XXX)**

WHEREAS the Council for The Corporation of the City of Brampton has adopted and the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001*, a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending THROUGH HIGHWAYS (Schedule III), NO PARKING (Schedule XIV), FIRE ROUTES (Schedule XXII) and RATE OF SPEED (Schedule X);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:
