ENACTS as follows:


1. By-law 200-82, as amended, is hereby further
amended:


(1) by changing on Sheet 29 of Schedule A
thereto, the zoning designation of the lands
shown outlined on schedule A to this by-law
from RESIDENTIAL TOWNHOUSE (R3A) to
RESIDENTIAL TOWNHOUSE - SECTION 377 (R3A -
SECTION 377).


(2) by adding thereto the following section:

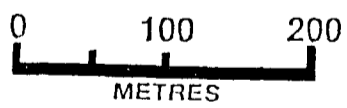
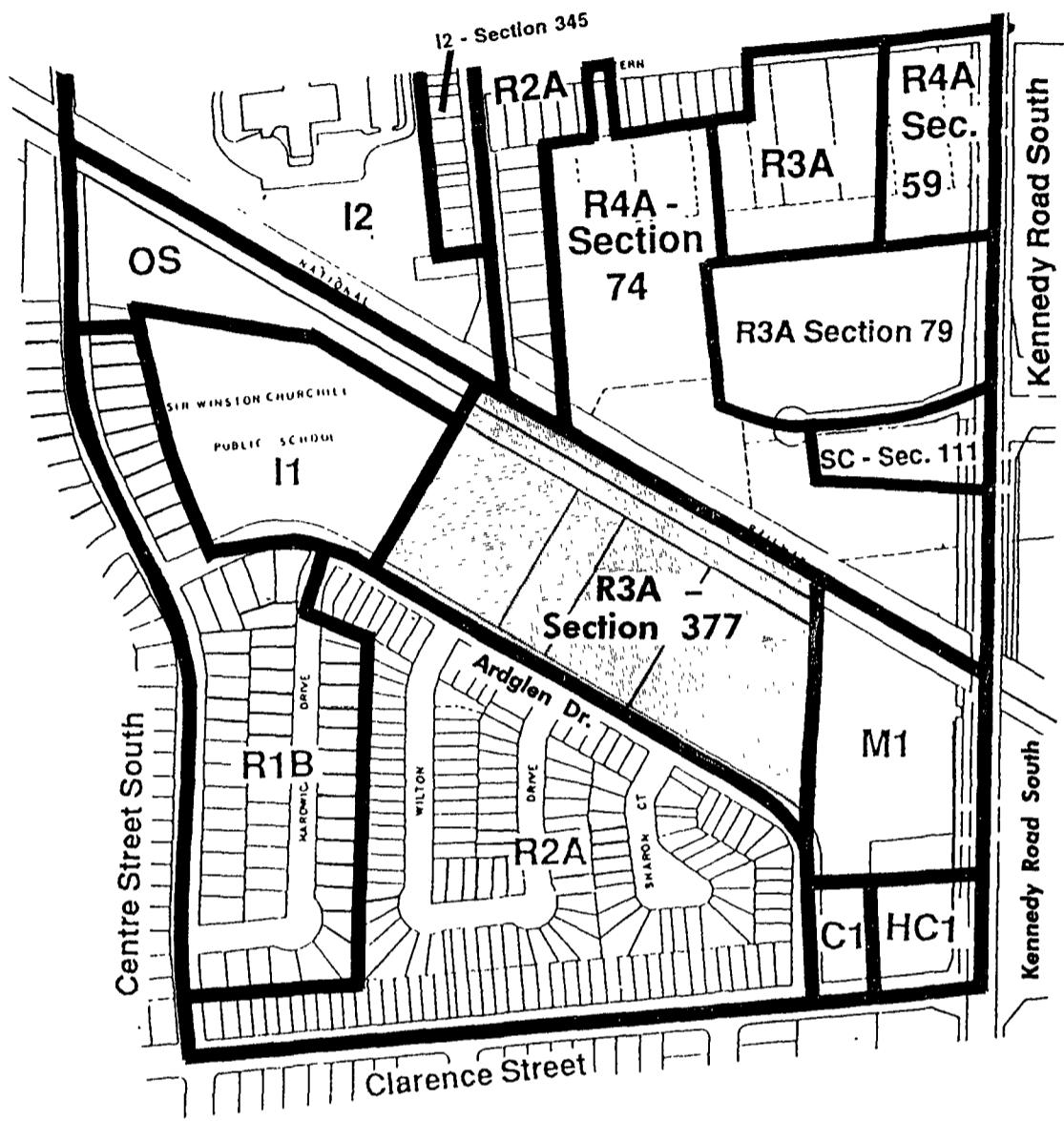
"377 The lands designated R3A - Section
377 on Sheet 29 of Schedule A to
this by-law shall be subject to the
requirements and restrictions of
the R3A zone except that more than
one accessory building shall be
permitted provided that such
accessory buildings are used for
lot maintenance purposes."




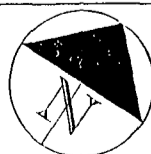
