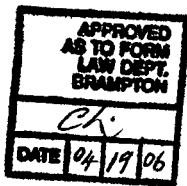
The Council of The Corporation of the City of Brampton ENACTS as follows:

this **24<sup>th</sup>** day of **APRIL** 2006.



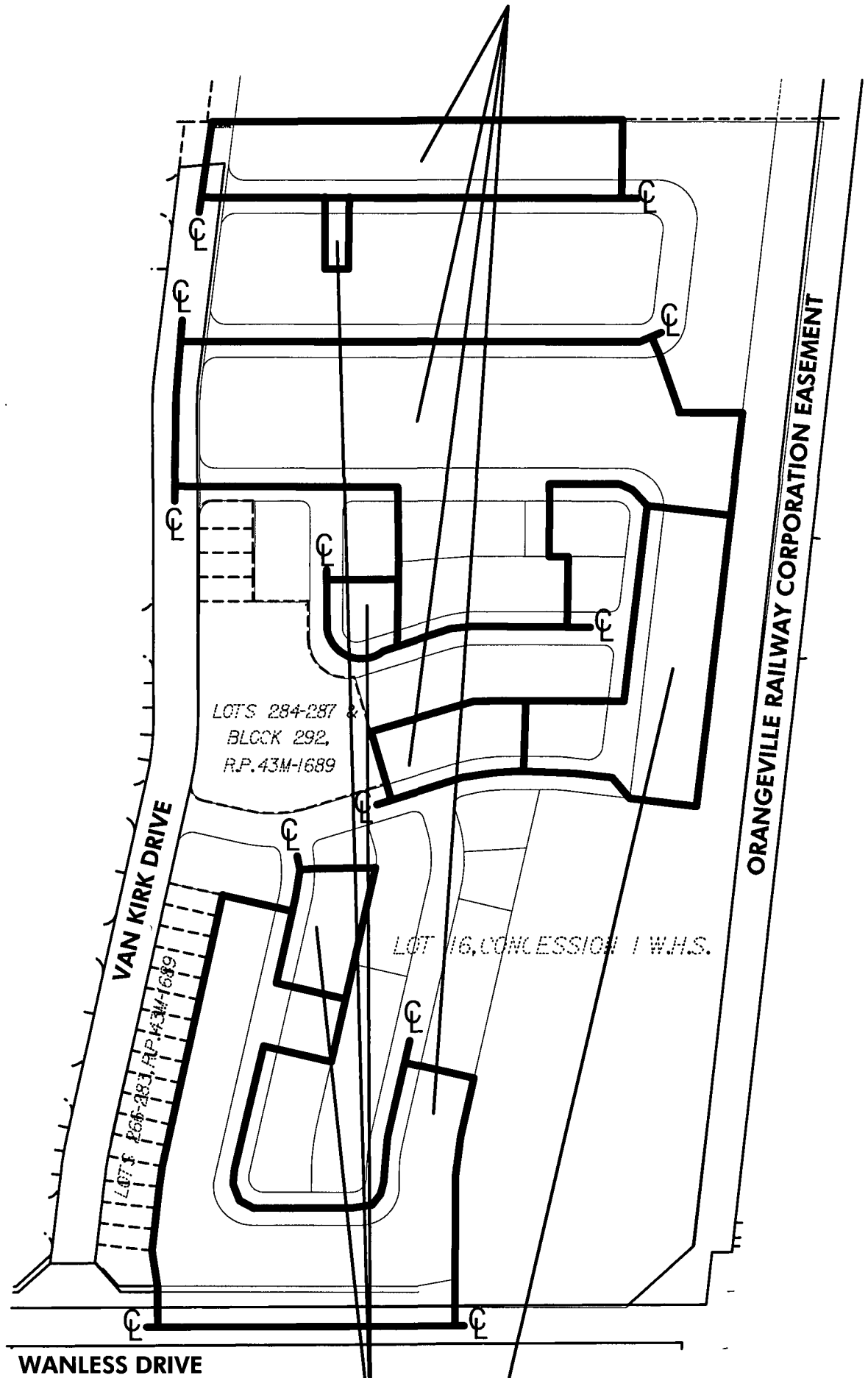

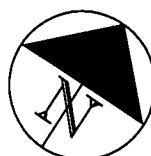
ZONE BOUNDARY


I, Joan LeFeuvre, of the Town of Halton Hills, in the Region of Halton, hereby make oath
