**To amend the Schedules of Traffic By-law 93-93, relating to U-TURNS
(Schedule II) and FIRE ROUTES (Schedule XXII)**

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending U-TURNS (Schedule II) and FIRE ROUTES (Schedule XXII);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following item from Schedule II:

U-TURNS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Sandalwood Parkway East	A point 10 metres west of Sandalwood Parkway East and a point 10 metres east of Sandalwood Parkway East

2. By-law 93-93 as amended, is hereby further amended by ADDING the following item to Schedule II:

U-TURNS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Sandalwood Parkway East	A point 10 metres west of Sunny Meadow Boulevard and a point 10 metres east of Sunny Meadow Boulevard


3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XXII:


City Council Meeting – Adoption of By-laws
