BY-LAW

Number 145-2007

To amend Traffic By-law 93-93,
by amending Schedules relating to Fire Routes,
School Bus Loading Zones, Parking Meters, No Stopping, Heavy Trucks,
Through Highways, Speed Limits, and Designated Turning Lanes

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93, as amended, is further amended as follows:

(1) by adding to Schedule III the following item:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Humberwest Parkway	The south limit of Castlemore Road and the north limit of Queen Street East

(2) by deleting from Schedule III the following item:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Humberwest Parkway	The south limit of Williams Parkway and the north limit of Queen Street East

(3) by adding to Schedule VI the following item:

DESIGNATED TURN LANES

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN	COLUMN 3 LANE	COLUMN 4 DIRECTION	COLUMN 5 COMPULSORY TURN
Humberwest Parkway	Castlemore Road and a point 200 metres south thereof	Second and third lane west of east curb	Northbound	Left

(4) by adding to Schedule VIII the following item:

Rutherford Road North	East	A point 40 metres north of school driveway and a point 25 metres southerly thereof	Gordon Graydon Senior Public School

(5) by deleting from Schedule VIII the following item:

(6) by adding to Schedule X the following item:

(9) by adding to Schedule XV the following item:

John Street	South	Main Street South and Chapel Street	Anytime

(10) by deleting from Schedule XX the following item:

PARKING METERS (On Street)






