To amend Interim Control By-Law 306-2003, An Interim Control By-Law applicable to Part of the Area Subject to By-Law 270-2004, as amended.


The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-Law 306-2003 as amended by By-Law 305-2004, is hereby further amended as follows:
 - 1.1 Section 1 is amended by adding after the words "Except as provided for in Section 1.1, Section 1.2 and Section 1.3", the following:


"and Section 1.4"
 - 1.2 The following is added as Section 1.4:

"1.4 The lands described as Part of Lot 11, Concession 6 W.H.S. and referenced as the "Lands Subject to Specific Exemption From Interim Control By-Law 306-2003, as amended by By-Law 154.2009" as outlined on Schedule A to this by-law shall permit renovations or additions to existing buildings or structures to a maximum gross floor area of 2400 square feet."
 - 1.3 Schedule A is deleted and replaced with Schedule A attached to this By-Law.


I, Earl Evans, Deputy Clerk, City of Brampton, in the Region of Peel, hereby make oath
