To authorize the execution of
a cost sharing agreement with
Whispering Willow Land Development Inc.

WHEREAS, in order to service new development proposed by Whispering Willow Land Development Inc. for Lots 12 and 13, Concession 5 EHS, it is necessary to extend the public highway known as Sandalwood Parkway east from Bramalea Road;

AND WHEREAS it will be necessary to acquire certain lands fronting on the east side of Bramalea Road to allow the Sandalwood Parkway extension to occur;

NOW THEREFORE the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:**


1. The Mayor and Clerk are hereby authorized to execute an agreement with Whispering Willow Land Development Inc., in a form approved by the City Solicitor, respecting the sharing of the costs of land acquisition for the extension of Sandalwood Parkway immediately east of Bramalea Road.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 11th day of June, 2001.

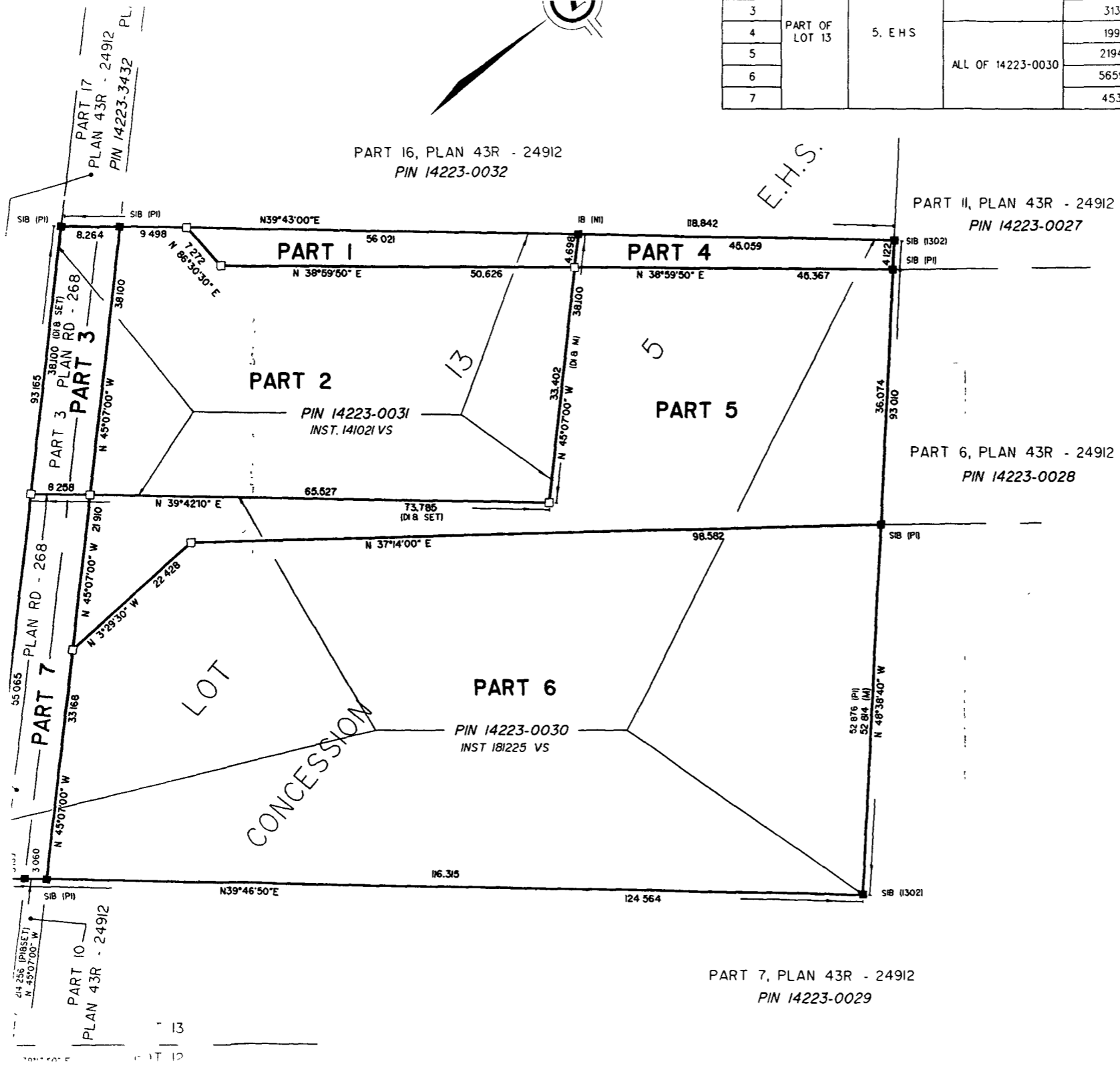
