BY-LAW

Number 198-93

To amend By-law 200-82, as amended,
(Part of Lot 6, Concession 1, W.H.S.
in the geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton
ENACTS as follows:

1. By-law 200-82, as amended, is hereby further
amended:

(1) by changing on Sheet Number 7 of Schedule A
thereto, the zoning designation of the land
shown outlined on Schedule A to this by-law
from RESIDENTIAL EXTENDED (R2B) to RESIDENTIAL
EXTENDED - SECTION 371 (R2B-SECTION 371), such
lands being Part of Lot 6, Concession 1, West
of Hurontario Street, in the geographic
Township of Chinguacousy.

(2) by adding thereto the following section:

"371 The lands designated R2B-SECTION 371
on Sheet Number 7 of Schedule A to
this by-law:

371.1 shall only be used for the following
purposes:

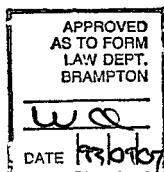
(1) either:

a) purposes permitted in an
R2B zone by 12.2.1, or

b) a parking lot as a
temporary use until
September 13, 1996;

but not both, and

(2) purposes accessory to the other
permitted purposes.



371.2 shall be subject to the following requirements and restrictions:


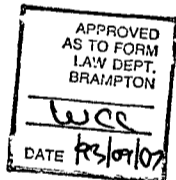
- (1) in respect of the purposes permitted by section 371.1(1)b), the requirements and restrictions relating to the SC zone, contained in section 23.1.1, shall apply.

371.3 shall also be subject to the requirements and restrictions relating to the R2B zone and all the general provisions of this by-law that are not in conflict with those set out in section 371.2."

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 13th day of September 1993.

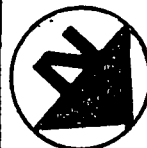
