BY-LAW

Number 205-87

To amend By-law 200-82 (part of Lot 1, Concession 2, W.H.S. in the geographic Township of Chinguacousy)

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. The zoning designation of the lands shown outlined on Schedule A to this by-law is changed from AGRICULTURAL CLASS 1 (A1), as provided in By-law 861, to RESIDENTIAL SINGLE - FAMILY C (RIC), RESIDENTIAL SINGLE-FAMILY D (R1D) and OPEN SPACE (OS), as provided in By-law 200-82, such lands being part of Lot 1, Concession 2, West of Hurontario Street, in the geographic Township of Chinguacousy.
2. By-law 200-82, as amended, is hereby further amended:
 - (1) by including, within the land to which By-law 200-82 applies the lands shown outlined on Schedule A to this by-law;
 - (2) by deleting the Key Plan of Schedule A thereto, and substituting therefor Schedule B to this by-law;
 - (3) by adding thereto, as Sheet 43 of Schedule A, Schedule C to this by-law;

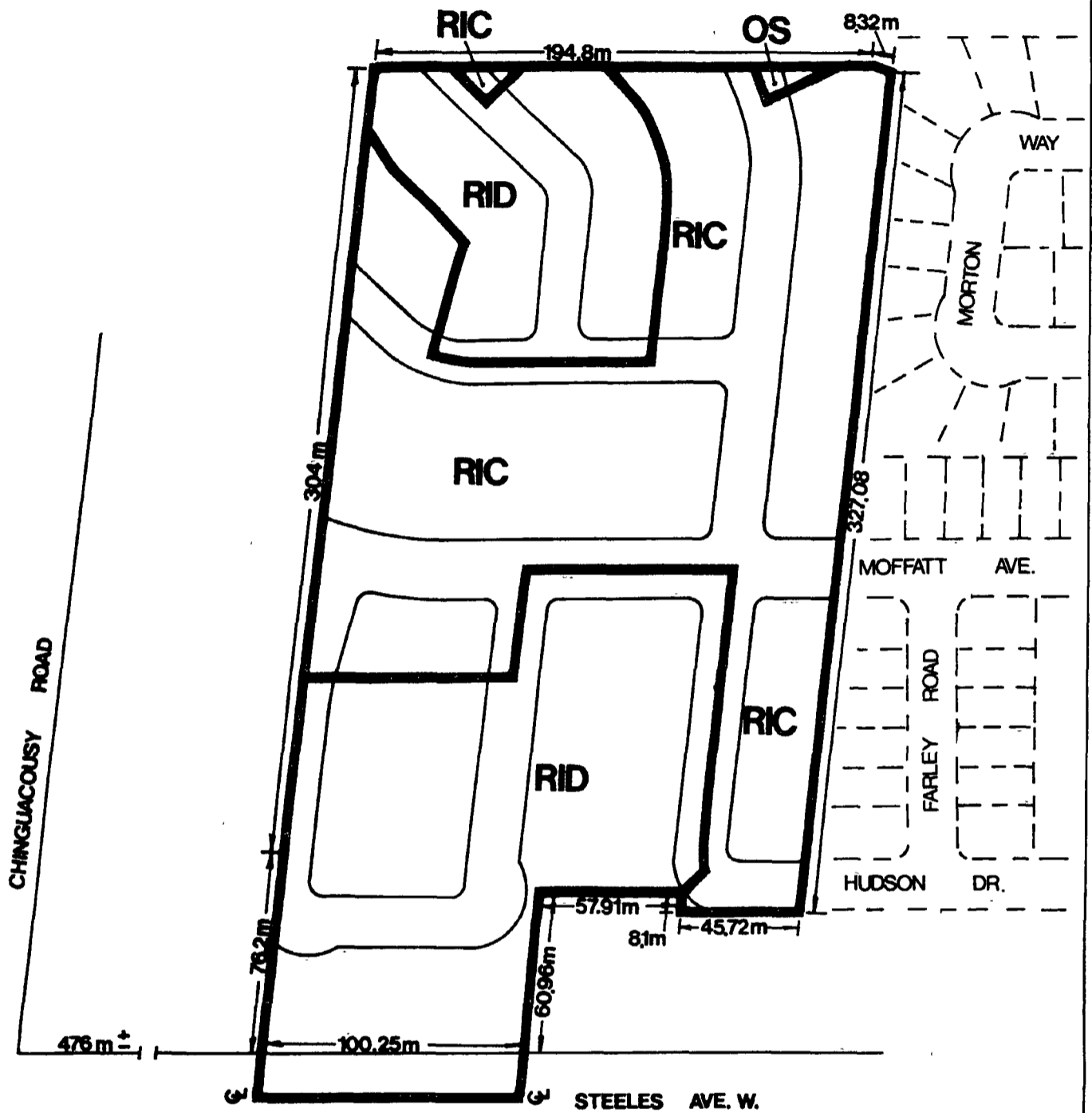

PART LOT 1, CON. 2, W.H.S. (CHING)

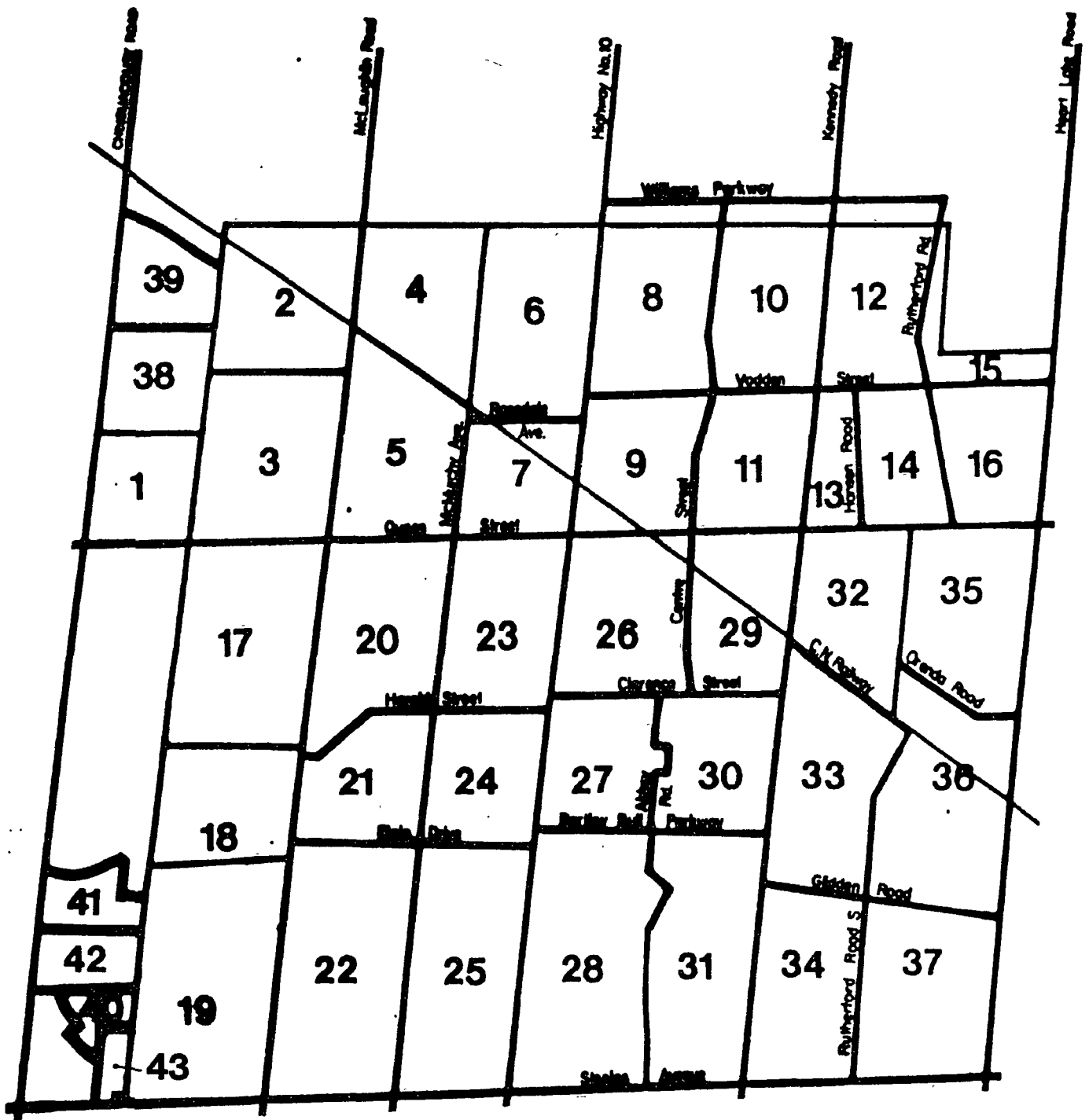

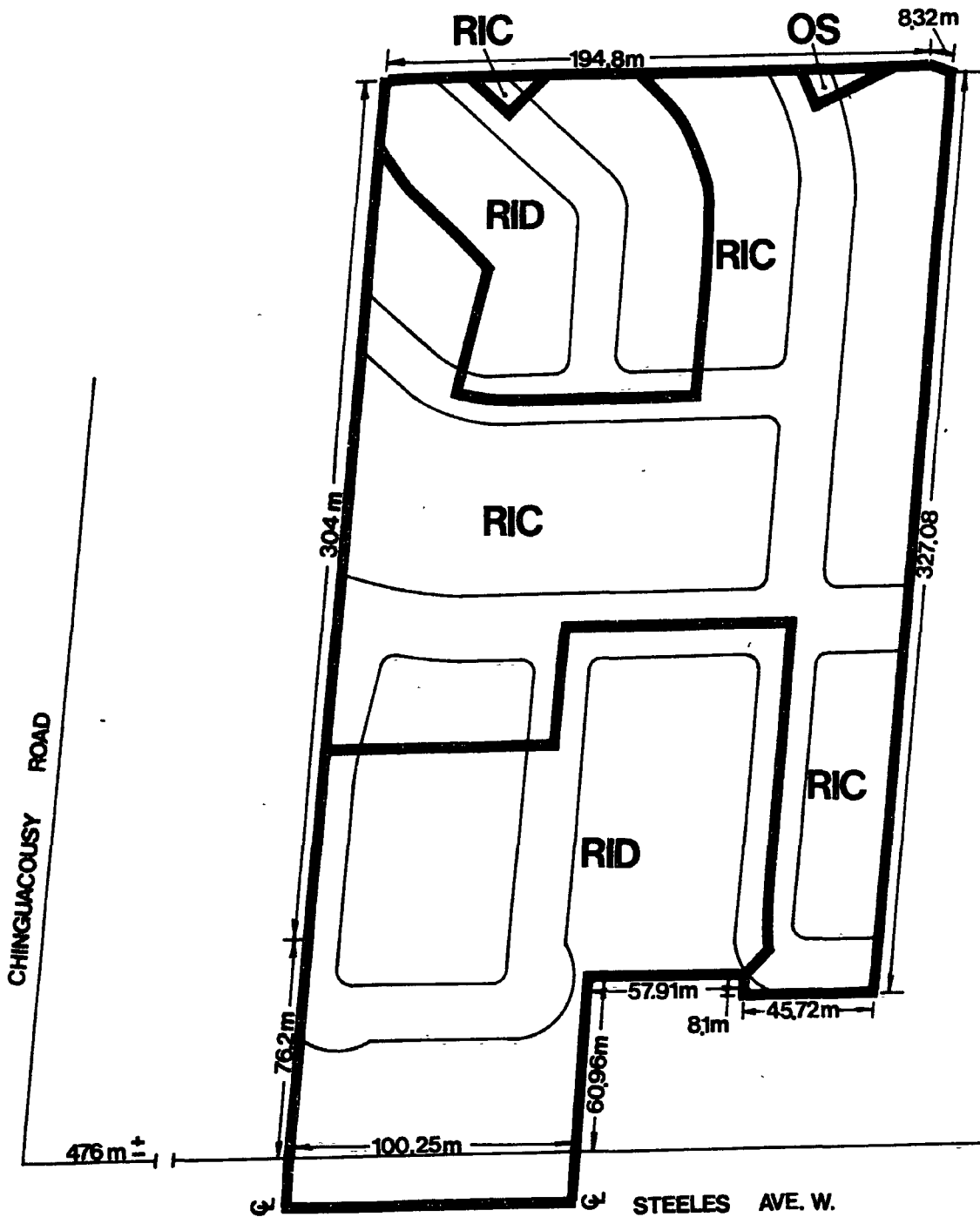
Schedule A Key Plan


