TO AMEND BY-LAW NUMBER 24-77  
DESIGNATING THROUGH HIGHWAYS.

WHEREAS THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON  
DEEMS IT EXPEDIENT AND ADVISABLE TO AMEND BY-LAW NUMBER 24-77,  
BEING A BY-LAW DESIGNATING THROUGH HIGHWAYS;

ADDITION THERETO OF THE FOLLOWING UNDER THE APPROPRIATE  
COLUMNS THEREOF:

COLUMN 1

THE SOUTH LIMIT OF BARTLEY BULL  
PARKWAY (EASTERLY INTERSECTION)  
AND THE SOUTH LIMIT OF MELVILLE  
CRESCENT (EASTERLY INTERSECTION)

WHEREAS THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON DEEMS IT EXPEDIENT AND ADVISABLE TO AMEND BY-LAW NUMBER 24-77, BEING A BY-LAW DESIGNATING THROUGH HIGHWAYS; NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON ENACTS AS FOLLOWS:

- 2. THAT SCHEDULE "A" TO BY-LAW NUMBER 24-77 BE AMENDED BY THE ADDITION THERETO OF THE FOLLOWING UNDER THE APPROPRIATE COLUMNS THEREOF:

COLUMN 1 HIGHWAY

DUNCAN BULL DRIVE

COLUMN 2 BETWEEN

THE SOUTH LIMIT OF BARTLEY BULL PARKWAY (EASTERLY INTERSECTION) AND THE SOUTH LIMIT OF MELVILLE CRESCENT (EASTERLY INTERSECTION)

- 3. THE PROVISIONS OF THIS BY-LAW SHALL NOT BECOME EFFECTIVE UNTIL APPROVED BY THE COUNCIL OF THE CORPORATION OF THE REGIONAL MUNICIPALITY OF PEEL.
