WHEREAS THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON  
DEEMS IT EXPEDIENT AND ADVISABLE TO AMEND BY-LAW NUMBER 147-77,  
BEING A BY-LAW DESIGNATING YIELD RIGHT-OF-WAY SIGNS AT  
INTERSECTIONS.

CREDITVIEW ROAD AND CHURCHVILLE ROAD	EASTBOUND ON CREDITVIEW ROAD

MUNICIPALITY OF PEEL.
