# BY-LAW

Number 221-2011

A By-Law to Amend User Fee By-Law 380-2003, as amended

WHEREAS By-law 380-2003 was passed pursuant to the *Municipal Act*, 2001, s. 391 (1) to impose fees or charges;


AND WHEREAS pursuant to Council Resolution C157-2011 approved by Council on August 10<sup>th</sup> 2011, it is deemed appropriate to amend By-Law 380-2003;


NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That By-law 380-2003 is hereby amended by replacing Schedule I, Financial and Information Services Department Fees/Charges with the Schedule set out in Appendix 1 to this by-law.
2. This by-law shall come into force and effect as of August 11<sup>th</sup>, 2011.

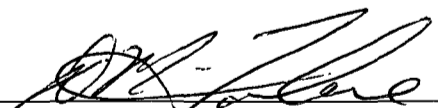
