A by-law to amend By-law 7-92 being a by-law to licence dogs, and to prohibit the running of dogs at large and to carry out the operation of the Brampton Animal Shelter and Pound

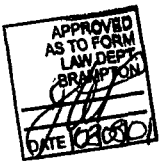
The Council of the Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. By-law 7-92 is hereby amended as follows:
  - (1) All references to "Schedule A" and "Schedule B" in By-law 7-92 are deleted and replaced with the words "Schedule 1";
  - (2) Schedules A and B to By-law 7-92 are repealed and the attached Schedule 1 is added as Schedule 1 to By-law 7-92.
