To amend By-law 151-88, as amended.

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:
 - (1). by changing on Sheet 21A of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to OPEN SPACE - SECTION 1073 (OS-Section 1073)
 - (2). By adding thereto, the following section:

" 1073.1 The lands designated OS - Section 1073 on sheet 21A of Schedule A to this by-law:


1073.1.1 shall only be used for the following purposes:

 - (1) sports fields;
 - (2) parking lot;
 - (3) temporary storage facility for equipment associated with the permitted use.

1073.1.2 shall also be subject to the requirements and restrictions relating to the OS zone and all the general provisions of this by-law.

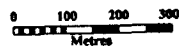
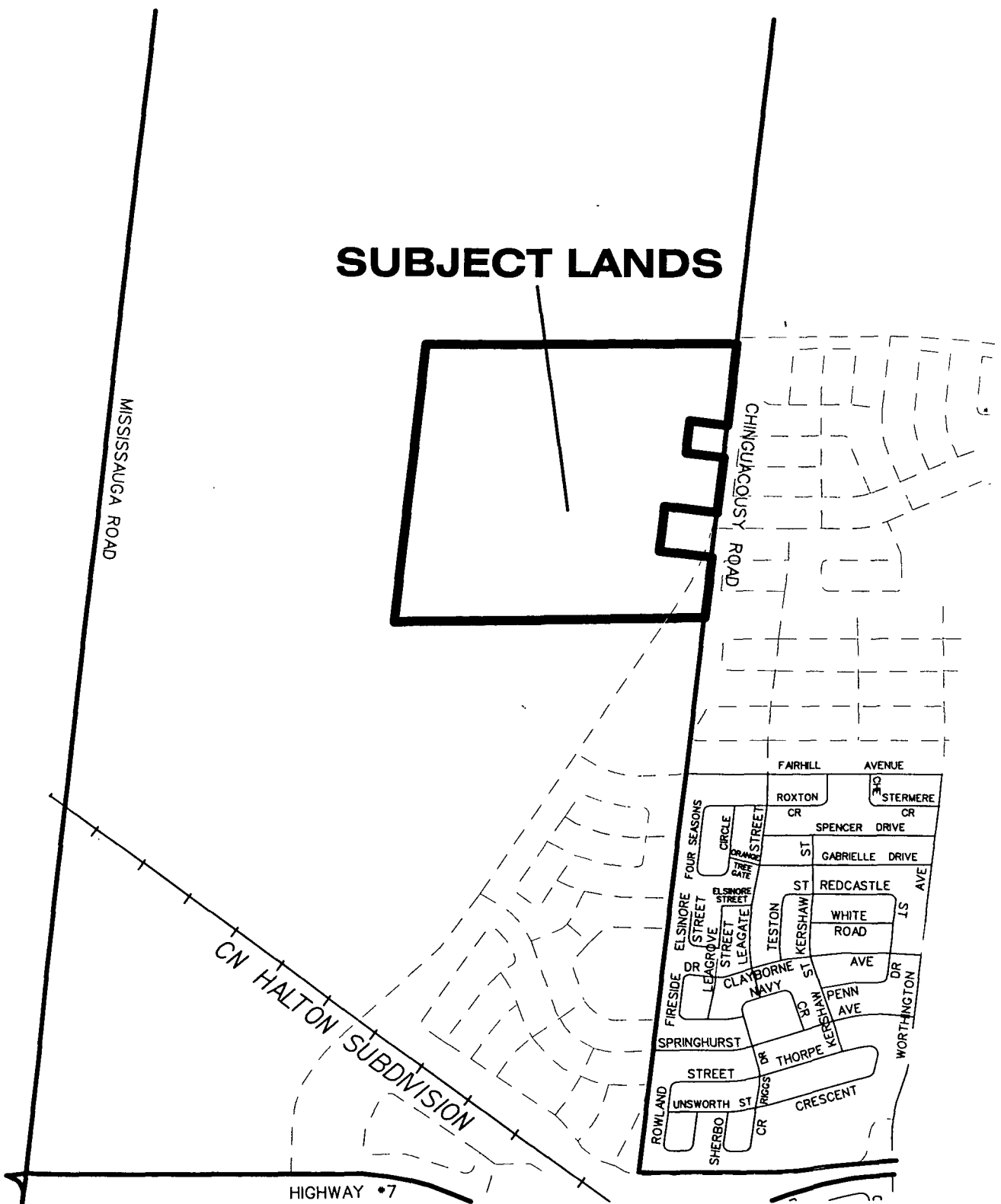

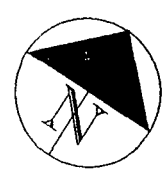

SUBJECT LANDS



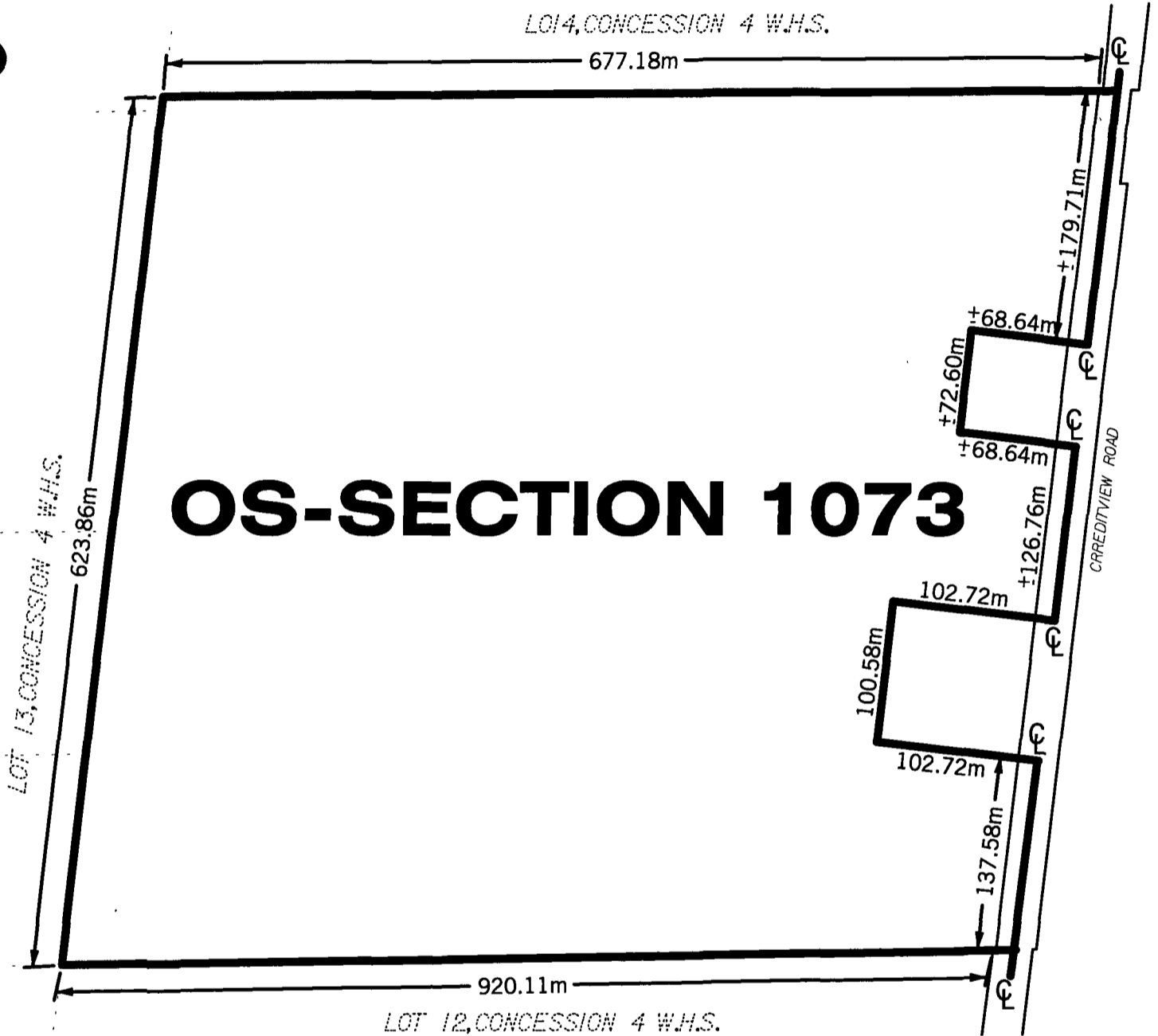
Key Map By-Law 237-2001

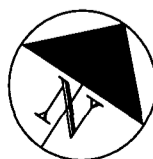


