
WHEREAS the Council of the Corporation of the City of Brampton desires to undertake the reconstruction of certain roads as set out in Schedule "A" attached hereto;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

1. That the Council of the Corporation of the City of Brampton shall undertake the reconstruction of those streets as set out in Schedule "A" attached hereto at a total estimated cost of \$690,000.00.
2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of the Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$690,000.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 24th day of September, 1979.

<p>C. <u>AINTREE CRESCENT FROM ALTON COURT TO ALGONQUIN BOULEVARD</u></p> <p>Reconstruction of Aintree Crescent from Alton Court to Algonquin Boulevard including storm sewers, excavation, granular base, concrete curb and gutter, asphalt paving, boulevards and related works.</p>	
<p>D. <u>ACTON COURT FROM AINTREE CRESCENT TO END OF ALTON COURT</u></p> <p>Reconstruction of Acton Court from Aintree Crescent to the end of Alton Court including storm sewers, excavation, granular base, curb and gutter, asphalt paving, boulevards and related works.</p>	
<p>TOTAL ESTIMATED COST OF A, B, C &amp; D</p>	<p>\$375,000.00</p>
<p>E. <u>MCCAUL STREET FROM SOPHIA STREET TO KENNEDY ROAD</u></p> <p>Reconstruction of McCaul Street from Sophia Street to Kennedy Road including storm sewers, excavation, granular base, concrete curb and gutter, asphalt paving, boulevard and related works.</p>	<p>\$315,000.00</p>
