
To authorize the execution of an Agreement between The Toronto Area Transit Operating Authority and The Corporation of the City of Brampton.

The Council of The Corporation of the City of Brampton ENACTS as follows:

That the Mayor and the Clerk are hereby authorized to execute an Agreement between The Toronto Area Transit Operating Authority and The Corporation of the City of Brampton, attached hereto as Schedule "A".

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 24th day of September, 1979.

DEMONSTRATION PROJECT - FARE INTEGRATION

THIS AGREEMENT made in duplicate this 1ST day of
October, 1979.

BETWEEN:

THE CORPORATION OF THE CITY OF BRAMPTON,
hereinafter called the "City",

-and-

THE TORONTO AREA TRANSIT OPERATING AUTHORITY,
hereinafter called the "Authority",

WITNESSES that in consideration of the mutual covenants and agreements herein contained, and subject to the terms and conditions hereinafter set out, the parties hereto agree as follows:

1. The City agrees:

- (1) to permit adults to travel to the Brampton or Bramalea GO Station on public transit vehicles operated by the City by using GO Transit tickets or passes with "Brampton" marked thereon as the departure point, in the form shown in Schedule A attached hereto;
- (2) to permit adults to travel from the Brampton or Bramalea GO Transit Station on public transit vehicles operated by the City by using a transfer provided by the Authority, in the form shown in Schedule A attached hereto; and
- (3) to submit monthly to the Authority an invoice for an amount equal to a figure calculated by multiplying the total number of passengers carried under this programme by 43.75¢.

2. The Authority agrees:

- (1) to supply and sell all tickets or passes which may be required for the operation of this programme, and to supply all transfers required for the operation of this programme; and


(2) to pay to the City, within 30 days after an invoice is submitted to it, the amount set out in the City's monthly invoice prepared in accordance with clause 1(3).

3. It is agreed that:


- (1) the term of this agreement shall be from Monday, 1 October 1979, to Friday, 28 March 1980, both days inclusive;
- (2) that only adult passengers, as defined by the parties hereto, may be permitted to take advantage of this fare integration programme;
- (3) no advertising will be undertaken unless it is acceptable to and approved by representatives of both the City and the Authority;
- (4) that all advertising for this fare integration programme is to clearly indicate that the programme is for a trial period of six months only, and that the continuation of the programme is not guaranteed beyond the initial six month period; and
- (5) all advertising costs shall be shared between the parties equally.
