AMENDMENT NUMBER OP93- 8
TO THE OFFICIAL PLAN OF THE CITY
OF BRAMPTON PLANNING AREA

1.0 Purpose:

The purpose of this amendment is to add to the list of amendments pertaining to Secondary Plan Area 18: Brampton East Industrial to include Amendment Number 8 A to the document known as the 1984 Official Plan.

2.0 Location

The lands subject to this amendment are described as Part of Lot 5, Concession 2, E.H.S., in the former geographic Township of Chinguacousy, now in the City of Brampton. The lands are situated on the east side of Rutherford Road approximately 106 metres (347.7 feet) north of Clark Boulevard. The lands have an area of 1.4 hectares (3.5 acres).

3.0 Amendment and Policies Relative Thereto:

3.1 Amendment Number 8 :

The document known as the Official Plan of the City of Brampton Planning Area is hereby amended:

- (1) by adding to the list of amendments pertaining to Secondary Plan Area 18: Brampton East Industrial as set out in Part II: Secondary Plans, Amendment Number 8 A to the document known as the 1984 Official Plan.
