Being a By-law to Amend By-law
Number 825 as amended of the former
Township of Toronto Gore.


The Council of the City of Brampton ENACTS as follows:

1. That By-law Number 825 as amended of the former Township of Toronto Gore be, and the same are hereby amended to rezone the lands described in Schedule 'A' hereto attached from Zone 'A' (Agricultural) to ER (Estate Residential).
2. That Schedule 'A', the zoning map forming part of By-law Number 825 as amended, is hereby amended by the addition to Schedule 'A' of the said By-law Number 825 of the land described in Schedule 'A' hereto attached.
3. That all of the regulations set out in Section VI(A), Estate Residential of By-law Number 825 as amended shall apply to the lands described on Schedule 'A' hereto attached with the exception that the minimum lot frontage shall be two hundred (200) feet.
4. That this By-law shall not come into force and effect unless and until approved by the Ontario Municipal Board.

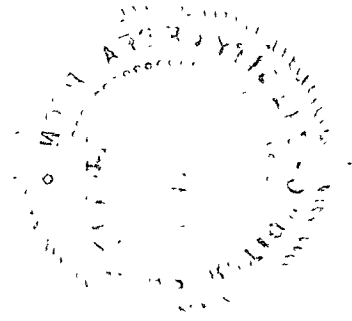

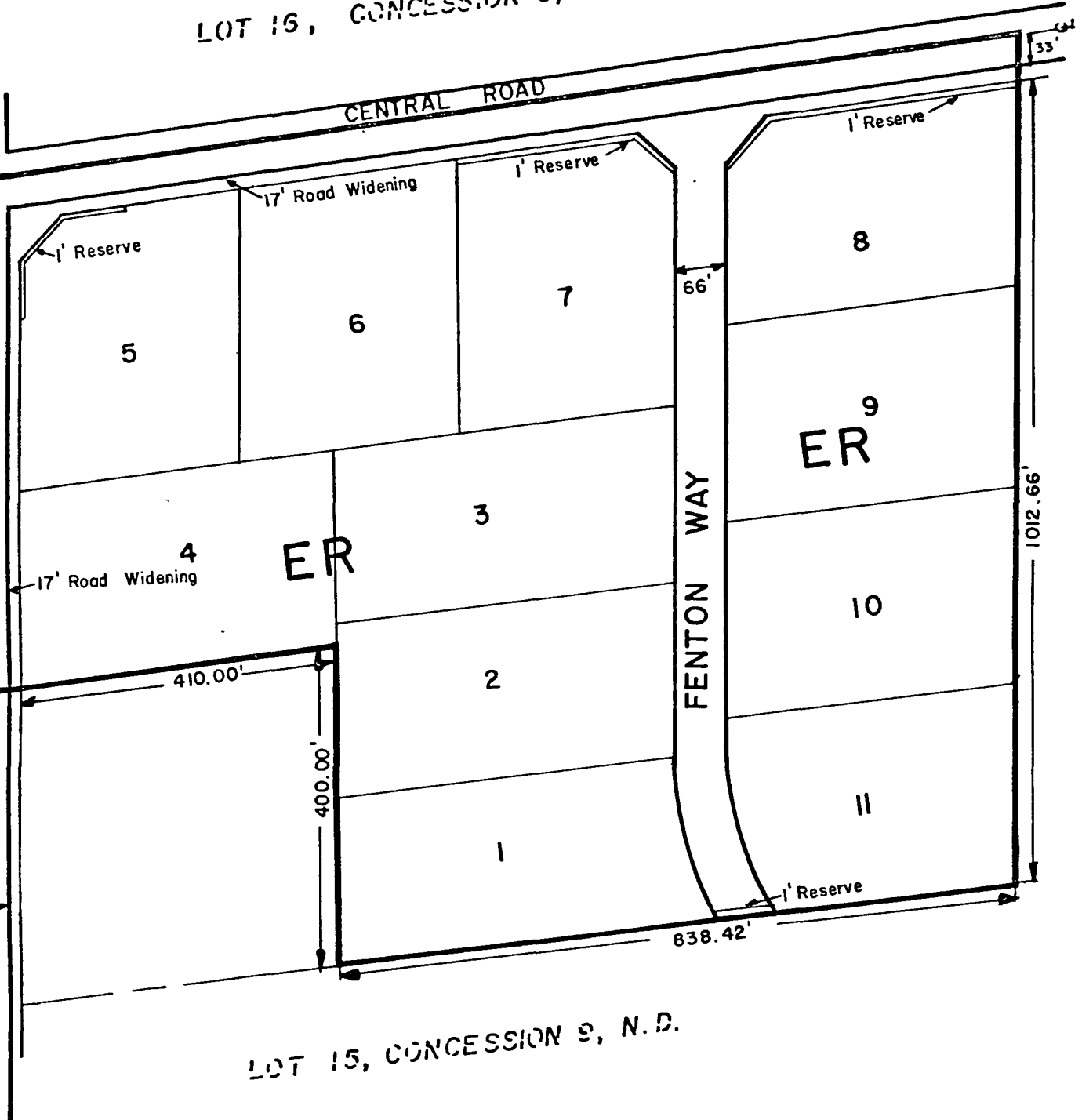
LOT 15, CONCESSION 9, N.D.

CENTRAL ROAD

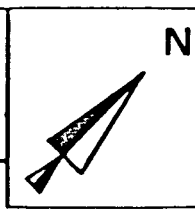

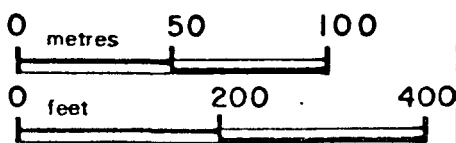

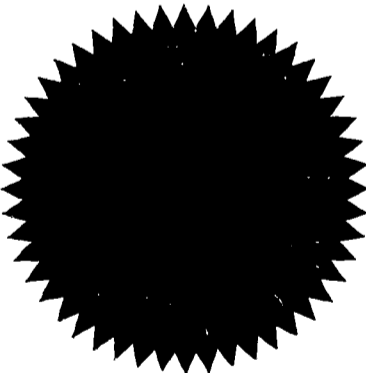
