

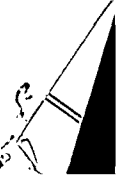

MEMORANDUM OF AGREEMENT made in triplicate this  
ninth day of October, A.D.1980,

BETWEEN: HER MAJESTY THE QUEEN in right of the  
Province of Ontario as represented by the  
Minister of Transportation and Communications,  
hereinafter referred to as the "Minister"

OF THE FIRST PART,

-and-

THE CORPORATION OF THE CITY OF BRAMPTON,  
in the Regional Municipality of Peel,  
hereinafter referred to as the "City"

OF THE SECOND PART.

WHEREAS the City proposes to carry out a study of the  
transit services provided by the City of Brampton;

AND WHEREAS the City's Transit Department described  
the proposed study to be carried out in a Memorandum to the  
Brampton Transit Committee dated the 14th day of July 1980;

AND WHEREAS the study will be carried out by the  
City with the assistance of temporary staff and selected  
Consultants;

AND WHEREAS the cost of the study to the City is  
Thirty-Six Thousand Dollars (\$36,000.00) and the City has  
requested the Minister to contribute seventy-five percent (75%)  
of the cost, namely, Twenty-Seven Thousand Dollars (\$27,000.00):

NOW THEREFORE THIS AGREEMENT WITNESSETH that in  
consideration of the premises and the covenants hereinafter  
contained, the parties hereto for themselves and their respective  
successors and assigns hereby mutually agree each with the other  
as follows:

1. That the City will carry out a study of the transit services  
provided by the City.
2. That a Study Committee will be appointed consisting of  
representatives of the Minister, Brampton Transit,  
The Toronto Area Transit Operating Authority, the  
Transportation Planning Division of the Regional Municipality


of Peel and the Planning Department of the City who will have the general direction of the Study.

3. That the study of the public transit services and operations and forecast of requirements to the year 1984 will be carried out in the following manner:
  - (i) the refinement of the existing set of standards for the evaluation of existing and proposed routes;
  - (ii) the evaluation of transit level of service presently provided by the existing system;
  - (iii) the determination of the short term transit service requirement up to and including 1982;
  - (iv) the determination of the intermediate term transit service requirements up to and including 1984;
  - (v) the identification of missing roadway links which may be required to provide efficient transit service in the short and intermediate term.
4. That the cost of the study shall not exceed the sum of Thirty-Six Thousand Dollars (\$36,000.00).
5. That the Minister will contribute a sum equal to seventy-five percent (75%) of the cost of the study which in any event shall not exceed Twenty-Seven Thousand Dollars (\$27,000).
6. That the Minister shall not make any payment to the City for any part of the study that in the opinion of the Minister is not an integral part of the study.
7. That the Minister shall pay the share of the cost of the study attributable to him to the City forthwith upon receipt of an invoice or invoices for the same approved by the Study Committee paid by the City in such form and detail as the Minister may require.
8. That the City shall retain all records and data collected or produced in the course of making this study for a period of five (5) years from the date of the receipt by the City of the study and report and make the same available to the Minister upon request.



- 9. That the City shall supply the Minister with ten (10) copies of the report resulting from the study, free of charge.
- 10. That the City warrants that it has done all acts and obtained all approvals that are necessary to authorize the City to enter into this agreement.

IN WITNESS WHEREOF the Minister of Transportation and Communications on behalf of the party of the First Part has hereunto set his hand and the party of the Second Part has affixed its Corporate Seal attested by the hands of its proper officers duly authorized in that behalf.
