Number 301-87

To change the name of Linkdale Road
on Registered Plans M-26 and M-192

WHEREAS the Council of the City of Brampton deems it expedient to change the name of Linkdale Road on Registered Plans M-26 and M-192;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in The Brampton Guardian and the Brampton Times, newspapers having general circulation in the City of Brampton;


AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The name of the street shown as "Linkdale Road" on Registered Plan M-26, which is described firstly in Schedule A attached hereto, is changed to "Townsend Gate".
2. The name of the street shown as "Linkdale Road" on Registered Plan M-192, which is described secondly in Schedule A attached hereto, is changed to "Layham Gate".
3. The affidavit of Leonard J. Mikulich attached as Schedule B hereto shall form part of this by-law.

READ A FIRST, SECOND AND THIRD TIME, and PASSED, in open Council this 14th day of December, 1987.



**PUBLIC NOTICE OF
CHANGE OF STREET NAMES**

TAKE NOTICE that the Council of The Corporation of the City of Brampton proposes to enact a by-law pursuant to Paragraph 105 of Section 210 of the Municipal Act changing the names of the following public highways:

1. "Linkdale Road" as shown on Registered Plan M-26 to be changed to and to be known as "Townsend Gate";
2. "Linkdale Road" as shown on Registered Plan M-192 to be changed to and to be known as "Layham Gate";
3. The southerly leg of Griselda Crescent as shown on Plan 861, which abuts Lots 54 to 57 and 93 to 98 on said Plan 861, to be changed to and to be known as "Glen Echo Court".

It is the intention of City Council for these changes of street name to be effective on January 1, 1988.

Plans showing the location of the streets to be affected by the name change by-law may be inspected at the office of the Clerk during normal business hours. The proposed by-law will come before Council for its consideration at its regular meeting in the Council Chambers at the municipal offices, 150 Central Park Drive, Brampton on the 14th day of December, 1987 at the hour of 7:30 o'clock in the afternoon, and at that time, the Council will hear in person or by his counsel, solicitor or agent, any person who claims that he will be adversely affected by the by-law and who applied to be heard.
