Number 312-2011

To amend Interim Control By-Law 306-2003, An Interim Control By-Law applicable to Part of the Area Subject to By-Law 270-2004, as amended, and known municipally as 2594 Bovaird Drive West.

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-Law 306-2003 as amended by By-Law 305-2004, is hereby further amended as follows:

1.1 Section 1 is amended by adding after the words "Except as provided for in Section 1.1, Section 1.2, Section 1.3, Section 1.5, Section 1.6, Section 1.7, and Section 1.8", the following:



"and Section 1.9"

1.2 The following is added as Section 1.9:


"1.7 The lands described as Concession 6 WHS Part Lot 11 and referenced as the "Lands Subject to Specific Exemption From Interim Control By-Law 306-2003, as amended by By-Law _____" as outlined on Schedule A to this by-law shall permit an expansion up to 20,000 square feet of gross floor area to the main building located at the westerly property boundary approximately 212 metres north of Bovaird Dive West, and to permit a place of worship that includes two sanctuaries, two ministers' residences, and accessory uses up to 25,000 square feet of gross floor area to be generally located at the north east quadrant of the subject property."

1.3 Schedule A is deleted and replaced with Schedule A attached to this By-Law.

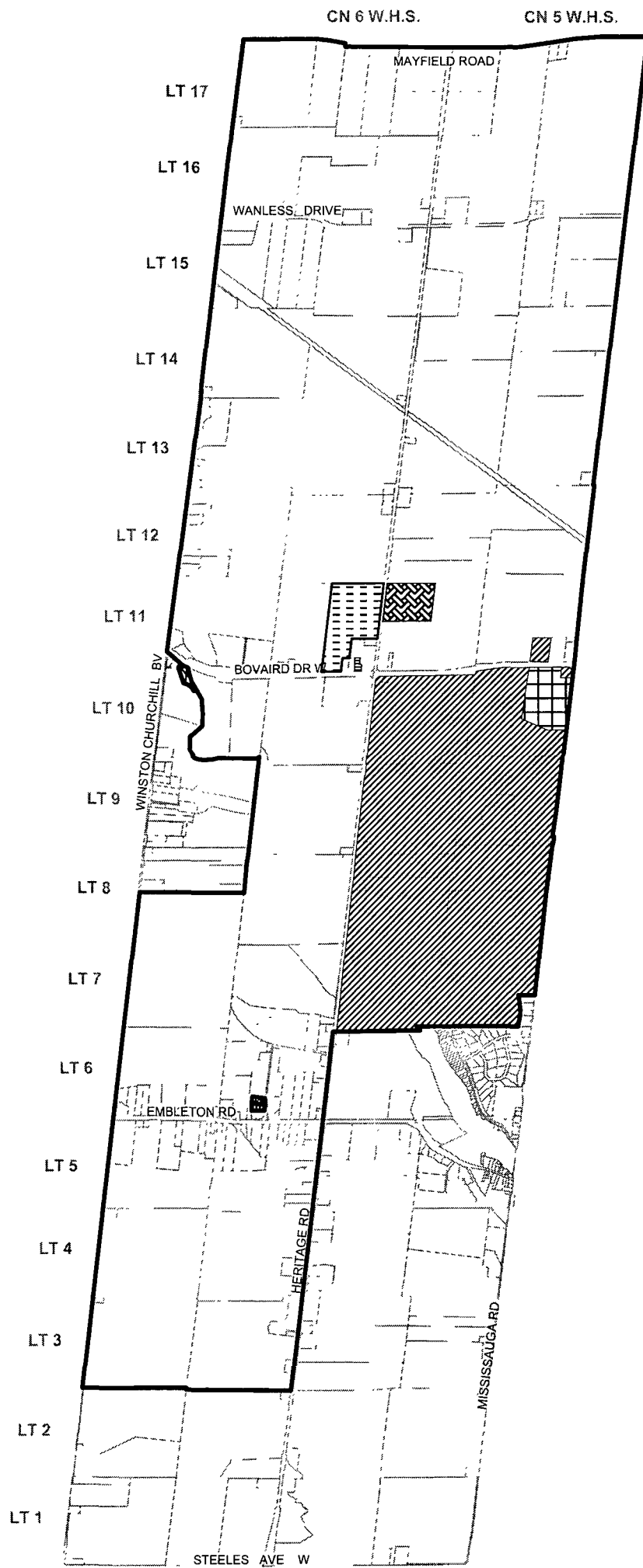
