A By-law to amend Licensing By-law 1-2002, as amended –  
Increase to Stationary Business License Fees


WHEREAS By-law 1-2002 was passed pursuant to *Municipal Act, 2001, S.O. 2001*, respecting the issue of licenses in the City of Brampton; and,

WHEREAS, pursuant to Recommendation CW477-2007, approved by City Council on November 28, 2007, it is deemed appropriate to amend fees related to Stationary Business Licenses;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That Licensing By-law 1-2002, as amended is amended by deleting Appendix A, Fee Schedule – License Fees, and substituting therefor Schedule A to this by-law.
2. That the Stationary License Fees set out in Schedule A to this by-law take effect for the applicable licenses issued for the licensing period starting January 1, 2008.
