BY-LAW

Number 396-2006

To accept and assume works in
Registered Plan 43M-1386, 43M-1440 and 43M-1489

WHEREAS the Council of The Corporation of the City of Brampton has, by resolution, decided that all works constructed and installed in accordance with the subdivision agreement for Registered Plans 43M-1386, 43M-1440 and 43M-1489 be accepted and assumed;

AND WHEREAS Council has authorized the City Treasurer to retain \$54,400.00 held by the City for the Model Homes on Worthington Avenue in connection with the registered plan 43M-1386;

AND WHEREAS Council has authorized the City Treasurer to release the securities held by the City in connection with the registered plans 43M-1440 and 43M-1489;

ANDWHEREAS it is deemed expedient to accept and assume the streets and street widenings on Registered Plans 43M-1386, 43M-1440 and 43M-1489 as part of the public highway system.

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby **ENACTS** as follows:

1. All of the works constructed and installed in accordance with the subdivision agreement for Registered Plan 43M-1386, 43M-1440 and 43M-1489 are hereby accepted and assumed.
2. The lands described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.
