Dear residents.

I hope you had a great summer and an opportunity to rest, relax and enjoy some time off with your family and friends.

I spent most of the summer visiting neighbourhoods and meeting with residents to hear your concerns and frustrations. I know the list is growing but I am working with our different City staff and departments to address the many issues related to illegal rooming houses, excessive on-street parking, the lack of property maintenance and speeding and reckless driving on our roads.

To those affected by the heavy rainfall and subsequent flooding that occurred on July 16, the Brampton Emergency Management Office (BEMO) has conducted a preliminary assessment of damage to residential properties and submitted information to the Ministry of Municipal Affairs and Housing's (MMAH) Disaster Recovery Assistance for Ontario (DRAO) program.

I remind you that as our children have begun going back to school, please continue to be careful and mindful while driving on our streets, especially in the school zones. Children are eager to get to school and play with their friends, and often forget about road safety and crossing the street without checking for cars. Please slow down and watch for pedestrians.

As the summer ends, I hope you had a chance to enjoy the warm weather and take some time to relax and recharge. Over the past few months, I had the opportunity to meet with many of you at our community events and had important conversations about your concerns and suggestions for how the City can better serve your needs. I am committed to ensuring that your voices are heard and that we work together to build a stronger community.

One key issue that has been raised repeatedly is the need for improved road safety. I have been working with our City teams to identify areas where we can implement traffic calming measures, enhance pedestrian crossings and address speeding concerns. In the coming weeks, we will see the installation of automated speed enforcement (ASE) cameras and speed cushions at several locations. The City has also announced the opening of its Automated Speed Enforcement Processing Centre. This centre will serve as a key component in the success of the ASE program, helping to deter speeding and prevent traffic collisions and tragedies, significantly strengthening the City's efforts to enforce road safety.

In addition to our focus on road safety, the City has made significant investments and improvements in our parks, recreation infrastructure, and the Residential Rental Licensing Pilot Program to create safer rentals for all. These investments demonstrate our commitment to enhancing the quality of life for all who call Brampton home. As always, I remain committed to being accessible and responsive to your concerns. Please do not hesitate to reach out to my office if you have any questions or concerns.



# WHAT YOU NEED TO KNOW WHEN IT SNOWS

Winter road crews begin plowing streets when there is five centimetres of accumulated snow, clearing major roads first. Parking on streets is not allowed and will be enforced during winter weather events. Penalties for parked vehicles interfering with snow removal have increased:

- first offence: \$125
- second offence: \$250
- subsequent offences: \$500

Residents must clear snow and ice from their sidewalks by 11 am the day after the end of a snowfall. To help seniors and people with disabilities who not only own, but also rent property, the City has expanded its Financial Assistance Program. Learn more at **brampton.ca/snow**

# PARKS AND RECREATION MASTER PLAN

Earlier this year, the City endorsed the Parks and Recreation Master Plan Five-Year Review and Update (PRMP). PRMP is a 15-year guiding document for the delivery of parks, open space, recreation and sports facilities to promote active and healthy lifestyles. Priority areas include uniting and supporting neighbourhood revitalization, connecting Bramptonians to the outdoors and planning for growth in greenfield areas. #### **WARD BOUNDARY REVIEW**

The City is conducting a Ward Boundary Review, which could affect which ward you vote in – and who you vote for – in the 2026 municipal election. The current ward boundaries were established in 2014. Since then, the city has grown in population, with some areas seeing more growth than others. The review aims to establish fair and equitable wards with better representation of citizens at Council. The review uses the principles of representation by population, future population trends, physical and natural boundaries and recognition of communities of interest to evaluate the existing ward structure and alternative options. ### **STORMWATER SAFETY**

Rain is an essential part of life, but too much rain can cause flooding, erosion and pollution. As climate change progresses, we are seeing more frequent and intense rainstorms. Taking small actions at home can reduce the harmful impacts of stormwater runoff.

Here are some steps you can take to protect your home from flooding:

- watch where the stormwater flows
- check the slope of your yard and downspout placement
- keep gutters, roof downspouts and drains clear
- cover construction materials or stockpiles to prevent debris from entering storm sewers

# LEADING THE WAY IN CREATING SAFER STREETS

Road safety is a top priority and the City is taking significant steps to address dangerous driving behaviours. Brampton's Automated Speed Enforcement (ASE) program uses cameras and speed measurement devices to enforce speed limits, reminding drivers to slow down. With 50 cameras currently in operation, the program will expand to 185 cameras by 2025, including the addition of a new regional processing center.

Stunt driving, as defined in the Highway Traffic Act, includes driving at excessive speeds, racing and other reckless actions. Those charged with stunt driving face severe consequences, including license suspension, vehicle impoundment and heavy fines. # PUBLIC CONSULTATION ON RESIDENTIAL RENTAL LICENSING IN WARDS 2, 6 & 8

The City of Brampton is undertaking public consultation on possibly expanding its residential rental licensing (RRL) program to Wards 2, 6 & 8 to address property standards and safety concerns. The program enforces property by-laws and the Ontario Fire Code to maintain neighbourhood character and protect renters. A two-year pilot program will evaluate its effectiveness, gathering insights on property conditions, safety and neighbourhood preservation. The results will guide the City's decision on whether to implement the program citywide, balancing the needs of renters, landlords and homeowners.



### CARBON MONOXIDE AWARENESS

Brampton Fire and Emergency Services urges you to protect your family from the dangers of carbon monoxide—an odorless, tasteless and invisible gas that can be deadly. ### PREPARE YOUR 72-HOUR EMERGENCY KIT

Emergencies can occur suddenly and help may take up to 72 hours to arrive. Ensure you're ready by assembling an emergency kit with non-perishable food, water, extra keys, cash, warm blankets, toiletries, a first aid kit, medications and pet supplies. Learn more at **brampton.ca/prepared** 



### DO NOT FEED WILDLIFE

Feeding wildlife is dangerous for both animals and residents. Residents must secure garbage bins, properly dispose of waste and pick up spilled bird seeds. Leaving food out, improper garbage disposal and spilled bird seeds are prohibited, including in residential areas and parks. Learn more at **brampton.ca/animalservices** 



#### TREES ON PRIVATE PROPERTY

Before having a tree removed from your property, the City's Urban Forestry team must be notified. Property owners do not require permission to prune privately owned trees. Visit **brampton.ca/trees** to learn about the Tree Preservation By-law and the role you play in protecting trees on private property.



### **FIREWORKS SAFETY**

Under the Fireworks By-Law, the use, purchase, discharge, possession, display, sale and offer to sell of fireworks is prohibited in Brampton. Sparklers are permitted. Penalties range from \$500 to \$1,000 and up to \$100,000 if a court summons is issued. Learn more at **brampton.ca/fireworks** 



# HOW TO PAY A CITY PARKING TICKET

If you receive a Penalty Notice for a parking infraction, you must pay or dispute it within 15 days of the date it is issued. Payments can be made online, in-person, by telephone or by mail. For details, visit **brampton.ca/APS**


